### Welcome to Genie's latest 'Village Matters' newsletter

### Big turnout to learn about the future of Goring & Woodcote Medical Practice

It was standing room only at Saturday morning's Patient Participation (PPG) Open Meeting in the Goring Village Hall

Drs Morris and Capo-Bianco provided a candid view of the pressures on keeping the Practice running and continuing to provide the high quality of care that we have all come to expect.

The audience of about 200

patients was presented with a number of ideas for helping to ease the load on the Practice, including looking after themselves and taking some responsibility for their own health and wellbeing; exercising, sensible diets and being careful with alcohol consumption. It was pointed out that the number of missed appointments was staggering and an appalling waste of valuable resources.



The use of an increasing number of available methods of electronic communications would further save GP and staff time. The audience was introduced to the use of the eConsult tool which was available on the Practice Website at <a href="https://goringwoodcotemedicalpractice.webgp.com/">https://goringwoodcotemedicalpractice.webgp.com/</a> and would provide information to patients and allow, if necessary, patients to seek answers from their GP. An answer could be expected in 48 hours or less. Patients were encouraged to register for systems such as Patient Access, Evergreen Life and the new NHS App all of which would provide access to health records and test result and avoid patients needing to phone in for this sort of information.



Such was the level of interest in the event the PPG and the Practice are now looking at re-running it in Woodcote in the

near future.

Members of the PPG, and any patients wishing to join the group, were encouraged by Jeremy Hutchins, Chair of the PPG, to sign up to Genie and tick the PPG newsletter box if they wish to receive the PPG's monthly newsletter. This is now the only method of receiving the newsletter.

## The world's best women cyclists race through Goring and South Stoke on 12 June towards Blenheim Palace

As anticipated, the fast-moving spectacle was watched by many local residents and school children along the route.

There were 96 riders (16 teams of 6) accompanied by around 30 marshals and TV cameramen on motorcycles. About 30 motorcycle police and police cars worked a 'rolling roadblock' to



allow the competitors to cycle flat out throughout the route. The whole 91 miles between Henley and Woodstock, near Oxford was covered by the winner, Jolien D'hoore from Belgium, in 3 hours 46 minutes with an average speed of 24mph. Overnight race leader Marianne Vos was one of a number of riders forced to abandon mid-stage following a crash involving many riders near Didcot, ten of which needed hospital treatment.

A message from the Goring & District Twinning Committee


An enormous thank you to everyone who hosted, helped, encouraged and/or participated in the Goring and District Twinning 40th Anniversary weekend on 7-10 June, when we welcomed 68 guests from Bellême including several first-time visitors. For details of the weekend's events and a report from the committee:

The Country Fair on Saturday was battered by challenging gusts of winds but was cheerfully relocated to the Village Hall whilst La Fraternelle Percheronne dancers and musicians visited Lyndhurst and The Grange to entertain residents there. In the

Village Hall there was a hubbub of camaraderie and lots of participation with the lively music of the Goring and Streatley Concert Band, and later La Fraternelle Percheronne. The various guided walks were extremely well attended and boat trips along the Thames were a highlight for many visitors.

A gala dinner on Saturday evening with entertainment from Goring Little Ukulele Group was enjoyed by 120 guests, with traditional chicken and leek pie and trifle supplemented by a wide variety of hors d'oeuvres and a cheeseboard. A slideshow of highlights from the past forty years tested the new Village Hall audio visual system and triumphed.

Sunday saw a coach trip to Oxford with various options including different guided tours in French and a visit to the Westgate Centre. A hog roast reinvigorated participants before a choral service/concert at St Thomas' Church which was much complimented by our French guests. A relaxing final evening with hosts followed, with a chance to group and regroup with quite a bit of sign language, before farewells on Monday morning.
