Closure of Streatley Hill (B4009) at Bull traffic lights extended to next Monday & Tuesday, 2 & 3 September 9.30am-5pm

Entitled *Victorian Carriages* the 2:39 minute clip shows Goring carriage collector, George Matthey, driving an 1870-built stage coach 'Perseverance' across the river bridge, with passenger and friend Sir

Arthur (Bomber) Harris, Marshall of the Royal Air Force, a resident of Goring for 30 years between 1954-1984.

A great lover of horses, George Matthey drove a carriage in the Coronation procession of Queen Elizabeth in 1952 and was a wealthy London businessman. He was chairman of his family bullion and rare metal dealership and during the second world war he made special aircraft parts in a factory he set up in the former brewery in Goring High Street. The manager of that business was Ronald Hare who had been in his employ for many years. Later Mr Hare (husband of Betty Hare who many residents will also know), acquired Spring Farm, Goring, where George Matthey kept his horses and collection of carriages.
